Dear Ms. Mastropietro,

In the December 30, 2015 LancasterOnline Article by staff writer Tom Knapp, titled - “Opposing rallies Saturday will protest, welcome Syrian refugees in Pennsylvania”, you were quoted as having said:

Anti-refugee groups have the right to protest, Mastropietro said. However, she said, “the rally will not stop Church World Service from carrying out our mission of promoting peace and justice throughout the world and providing a home for the displaced, and of fulfilling our contract with the U.S. Department of State to resettle refugees in the Lancaster area.” The Lancaster community, she added, “has a long tradition of welcoming strangers.”

First, contrary to your statement to LancasterOnline, we are not “Anti-refugee groups”. We are pro-constitution, law abiding Citizens of Pennsylvania and of the United States of America.

A private Citizen or private organization, using their/its own private funds and resources can lawfully sponsor a legal immigrant or a true refugee who actually flees to American soil. However, despite what you may believe or have been told, neither the State nor the federal government has any constitutional authority to use public funds and/or resources to resettle or relocate anyone within a State, the United States or a territory of the United States. Likewise, the government cannot lawfully pay to educate, find a job, house, support, etc., an immigrant or refugee. Therefore, any alleged “contract with the U.S. Department of State to resettle refugees in the Lancaster area” is clearly unconstitutional. Entering into and/or executing such a contract is equally a crime.

Our clear message is that working with and/or for the United States and the United Nations to “resettle refugees”, particularly Muslims, in Pennsylvania, the other States of the Union and the United States of America is **unconstitutional**.

Pennsylvania’s true history, Constitution and constitutional laws are **antithetical** to Islam and Sharia Law. **Sharia** Law or **Sharia** is the basic Islamic legal system derived from the religious precepts of Islam, particularly the Quran, the Hadith and other such teachings of Mohammad.

True Islam is a religious, political and military totalitarian worldview that tolerates no other. Either convert or die. Their objective is total dominance of the world. To this end, deceit and destruction from within are important strategies for their victory.

In support of the statements made herein, as well as other related matters, please read and understand the attached true, correct and complete copy of the December 14, 2015 “Open Letter” to Governor Thomas W. Wolf and his November 17, 2015 Letter to “Members” of the Pennsylvania House of Representatives. These two documents are incorporated herein by reference as if set forth in full at length.

Given the compelling history, facts and law presented and referenced herein, we sincerely recommend that Church World Service, and all those in leadership positions thereof, immediately revoke, make null and void, any and all applicable contract(s) with the U.S. Department of State and/or the United Nations, and stop any involvement with the State and United State “Refugee Resettlement” Processes/Programs now and in the future.

Thank you very much for your sincere, honest and objective full consideration of this letter and its attachments. We trust that you shall now correct your errors and act in accordance with Biblical and constitutional law.
