

## Press Release

A “Press Conference” is scheduled for January 23, 2024, at the Pennsylvania Capitol in the Rotunda from 10:00 am to 12:00 pm.

Over a year ago, William Taylor Reil, Founder and CEO of the *County Sheriff Brigades of Pennsylvania* (CSBP), introduced two documents that he has written and circulated. These documents are titled:

- 1) “**Outline for the discussion about the unlawful Amendment Process used in Pennsylvania**”, and
- 2) “**Outline for the discussion about the unconstitutional and unlawful Attorney General and District Attorneys in Pennsylvania**”

Mr. Reil has educated hundreds of Pennsylvania citizens and government officials, including Sheriffs, about these very serious documents via verbal or written communication. They all agree corruption has occurred; however, they are unsure of how to correct the issues outlined in the above-mentioned documents.

**Therefore**, Mr. Reil has scheduled a public “Press Conference” for **January 23, 2024**, at the **Pennsylvania Capitol in the Rotunda from 10:00 am to 12:00 pm** to briefly discuss the two “Outline for Discussion ...” documents. Mr. Reil shall also stress the lawful remedies required.

Mr. Reil will then explain that following the “Press Conference”, Pennsylvania citizens in attendance at the “Press Conference” will hand-deliver (serve) copies of these two documents and a personalized Notice and Demand “Open Letter” to the offices of approximately 300 State Government Officials/Officers and 50 established press reporters in Harrisburg and elsewhere in Pennsylvania.

Mr. Reil will also announce that after January 23, 2024, the County Coroner in each of the 67 Counties, as required by Title 231 Pa. Code § 400 ( c ) - Person to Make Service, will serve each County Sheriff with the above-mentioned documents and a personalized Notice and Demand “Open Letter.” In addition, Mr. Reil will have each County Commissioner or Home Rule Council Member, the District Attorney and the President Judge of the Court of Common Pleas in each of the 67 Pennsylvania Counties served with copies of the two “Outline for discussion ...” documents and a personalized Notice and Demand “Open Letter.”

Time will be allotted at end of the “Press Conference” for Questions and Answers.
