Dear Governor Shapiro,

This is a Notice and Demand “Open Letter”, respectfully prepared and submitted with sincere good faith and resolve.

We do this as sovereign Citizens of Pennsylvania and of the United States of America pursuant, at a minimum, to our constitutionally secured, protected and guaranteed Rights of “Freedom of Speech and Press” and “Petition for Redress of Grievances”. [Article I, Sections 1, 2, 7, 20, and 25 in the Constitution of the Commonwealth of Pennsylvania and the First Amendment in the “Bill of Rights” of the Constitution for the United States of America, respectively]

Attached are true, correct and complete copies of (1) an “Outline for the discussion about the unlawful Amendment Process used in Pennsylvania” and (2) an “Outline for the discussion about the unconstitutional and unlawful Attorney General and District Attorneys in Pennsylvania”. Many supporting documents are referenced and “sourced” in these two documents. All of these documents (two “Outline ...” and supporting) are incorporated herein by reference as if set forth in full at length.

The two “Outline ...” documents and the referenced/”sourced” documents are available to you on the *County Sheriff Brigades of Pennsylvania* (CSBP) website at: [www.sheriffbrigadesofpenn.com](http://www.sheriffbrigadesofpenn.com) by selecting “RESOURCES” on the top bar of the “Home page”; scrolling down to and clicking on “ADDITIONAL DOCUMENTS BY WILLIAM TAYLOR REIL”; then selecting the document title which you desire to read. Many more documents are available to provide additional conclusive proof as to the validity of the statements made in the presented “Outline ...” and referenced/”sourced” documents.

***These documents present overwhelming, conclusive evidence of very serious, ongoing and dangerous crimes!***

**Required Remedies:** Gov. Shapiro, your constitutional “Oath of Office” states: "I do solemnly swear (or affirm) that I will support, obey and defend the Constitution of the United States and the Constitution of this Commonwealth and that I will discharge the duties of my office with fidelity." [Article VI, Section 3]

**Therefore:** Gov. Shapiro, for all of the reasons stated and referenced herein above, the remedies required are: (A) Within 45 days after the receipt of this “Open Letter” and its attachments, issue a written Official Public Notice that the facts and laws presented in these documents are true and correct, and are binding on you according to your “Oath of Office”. Any fact, law, and/or statement, phrase, word etc. not so confirmed shall be explicitly and completely rebutted in writing using lawful evidence. Your “verified”, completed, sworn and signed written timely response shall be mailed to William Taylor Reil care of (c/o) the CSBP. and; (B) Personally study or restudy the true history and the Constitutions of Pennsylvania and for the United States of America. Understand that your “Oath of Office” requires you to closely examine everything that you have done or will do in your official capacity and to correct any errors that you have or may have made.

Everyone in government at any level, particularly Attorneys, Judges, Justices, Sheriffs, Constables and Police Officers, is forbidden from following or enforcing any unconstitutional laws, regulations, codes, rules, policies, mandates, court decisions, etc.. As Chief Justice Marshall stated in *Marbury vs. Madison*, 5 US (1 Cranch) 137, 180 (1803):

“Why does a judge swear to discharge his duties agreeably to the Constitution of the United States if the Constitution forms no rule for his government? if it is closed upon him and cannot be inspected by him? **If such be the real state of things, this is worse than solemn mockery. To prescribe or to take this oath becomes equally a crime.**

It is also not entirely unworthy of observation that, in declaring what shall be the supreme law of the land, the Constitution itself is first mentioned, and not the laws of the United States generally, but those only which shall be made in pursuance of the Constitution, have that rank.

**Thus, the particular phraseology of the Constitution of the United States confirms and strengthens the principle, supposed to be essential to all written Constitutions, that a law repugnant to the Constitution is void, and that courts, as well as other departments, are bound by that instrument.**”

and;

(C) Issue a public OFFICIAL NOTICE concerning remedies (A) and (B) to all those who report to you, directly or indirectly. and;

(D) Protect and Defend any Citizen or Citizens of Pennsylvania harmed as a result of the failure to provide these remedies. and;

(E) Aggressively support the enforcement and defense of all of the Rights of Pennsylvania Citizens and these remedies.
